The Water Committee members were at the meeting to discuss the new water district setup and work under the Water Grant nearing completion. A review of any billing issues and water usage on accounts is under review by the Water Committee for possible changes in the near future.

Regarding the Special Contract letters, they will be mailed as usual but will state that the fee in the letter is for the calendar year 2020. This will be the last Special Contract letter and there will now be a Genoa-King Ferry water tax on their 2021 Town and County taxes which will be for the year 2021. Two properties in the Water District will now have this tax on their 2021 T & C taxes even though they are not hooked up to the water and choose not to be.

Bob mentioned that one well has been cleaned.

Bob suggested that the Board investigate replacing the old district water lines.

The Board received a letter requesting funds for the Owasco Water Shed. The Board agreed that they would continue funding the Cayuga Lake Water Shed and not the Owasco Water Shed.

The Board discussed the 2021 Tentative Budget.
