# ASSESSOR REPORT

Lorie Sellen-Gross

I have the renewal exemption applications to mail to property owners receiving the LOW-INCOME Senior Citizen Exemption, LOW INCOME Disability Exemption and Agricultural Exemption. Property owners must apply each year by submitting the completed renewal application no later than March 1<sup>st</sup>. I am hoping to have them all

mailed just after Thanksgiving. I will need envelopes and am holding off for just a bit so I can include good details about this year's process.

I will be encouraging applicants to mail, or hand deliver applications and required documents to the Town Hall Assessment Drop Box to decrease the risk of Covid-19 exposure and spread.

During the winter months the residents needing the attention of the Assessor are primarily elderly, disabled and agricultural property owners. These groups represent those that are the highest risk to exposure and those with the highest risk for complications from the illness.

I understand that the risk of exposure may appear minimal and necessary precautions seem overly cautious, but I want to remind you that my husband has no immune system and ALL the factors that put one at high risk. A common cold for him typically results in further illness and a hospital admittance. My ultimate goal is to keep him healthy so I can focus on my work here. Limiting my contact with people and contaminated surfaces is the only strategy available currently. I hope you all understand the severity of this situation. I will be happy to discuss the details privately if you need further explanation.

The Town of Venice will be installing a secure sealed window in my office for the safety of myself and visitors. Once the installation is complete, I will begin office hours there and will meet with anyone who needs to see me in person by appointment. If this works out well, and with permission from the Town, I may expand the hours I am there to accommodate more residents.

The Town of Genoa has decided to update assessments for the 2021 assessment roll. So, I will be out and about updating photos and looking at each property as I value from now until Tentative Roll (May 1<sup>st</sup>) as well as updated property changes and value reviews as needed elsewhere.

The Board decided to start the hiring process with Mark Connor as parttime employee based on those needs. No benefits offered, only an hourly rate stipulated in the 2020 Organizational Meeting which will be reviewed again in January of 2021.
