OLD BUSINESS

A letter from the King Ferry Fire Department was sent to fire lane residents reiterating a letter sent in 2020 regarding the condition of some of the bridges and the fact that only the small pumper truck is able to drive on the fire lanes. A new letter is being drafted by the Code Officer, the Town and the KF Fire District.

A Public Hearing will need to be held before a decision can be made regarding the marijuana law.

NEW BUSINESS

A check was received from the County for sales tax revenue. The amount was \$246,189.57 Lorie received a letter from Zito stating that their rates are going up.

There has been a \$25 fee increase for the monthly administration fee for the health insurance plan. It is now \$75.

Dave Schenk, a member of the Cayuga County Watershed board reached out to the Town. They are working on putting sewer pipes on Honoco Road and he asked if the Town would be able to help financially. The Board declined.

Lorie submitted a FEMA application to Albany for assistance where the culvert washed out across the road from the Highway department.

The 2022 budget will be discussed further at the November 16 meeting.

The Town of Venice would like to share the services of our Town Attorney, Guy Krogh.

Ag & Markets sent a report on our dog control, Finger Lakes Dog Protection. They were rated satisfactory
