### **OLD BUSINESS**

A letter for approval was drafted and sent to the King Ferry Fire Chief, the King Ferry Fire District Commissioners. Fire Chief Shaw approved the letter, however; the Fire Commissioners were ambivalent with the letter as they felt too much liability fell on their shoulders. A decision was to hold off on the letter by the Fire District Commissioners until it was worded to their liking. The Town Board felt that a revised letter needs to come from the Fire Chief and the Commissioners now. The Town's Code Enforcement Officer will still work with them to resolve the issues on the fire lanes in King Ferry.

#### **NEW BUSINESS**

John Boles requested permission to fall a tree that is partially on the Town of Genoa's land and a property owner in Genoa who gave him permission to take it down from their portion of that property. The Board indicated that John could do this from the Town's perspective.

ARPA funds that the board wanted to designate to replace a few hundred feet of waterline from Mahaney Road east towards the water tower has been determined by Hunt Engineering that those funds would not be better used on town roads with shorter repair distance. The Board may consider changing the location to Academy Street or Stevens Street for future repairs. Hunt Engineering will be reviewing those areas once the Water Department determines what the best location will be.

A thank you note was received from Seneca Stone for doing business with them.

Paul has requested that the Town Board reinstate Eric Reeves in his past position, but only part time ad he may be needed to train the current new employees during snow plowing needs.
