NEW BUSINESS:

Jeff and Lorie Reeves: Permit has been issued by DEC for the mining of gravel Site boundary is 150' from Reeves' house

Letter which first outlined mining proposal is presented to Board

Reeves: Board should have seen and discussed letter so public concerns could have been returned to DEC before permit could be issued Underwood signed for receipt of letter in Rich Harrison's name but did not write his own name beneath and did not checkmark a box indicating he was acting as agent No response to letter was received by DEC within 30 days so permit process simply moved forward A legal notice regarding permit did appear in The Citizen but was not noticed by Reeves The DEC allegedly never looked at the site Map used by DEC shows the pond but does not show the house Operation of mine: hours when facility could be lit up and running Dust: an inevitable annoyance and a serious health hazard Affect on property resale value Noise: Machinery such as crusher, etc.

Tyrrell: Water run-off issues of mining

Shields: Foundation damage by vibration of ground Settling of earth caused by vibration Affect on nearby wells

Underwood: Damage to newly-refurbished Town roads by truck traffic Affect on other citizens in addition to Reeves

Reeves and Underwood: Phone calls to DEC: Joanne March and Nynette Their response: basically, the permit is issued, nothing needs to be done right now No mining is underway, no problems are are occuring which need to be addressed

Reeves: Want to act now as mining could begin at any time

Full board unified in considering situation important and time-sensitive

Strategies for response to situation discussed:

Underwood: Suggest writing letter Lorie Reeves: Want permit revoked and permit process begun again from beginning, with original mining proposal brought before open board meeting Guy Green: Reeves have very strong case to claim procedure was mishandled and permit could be revoked legally Reeves: perhaps call Albany? Underwood: Can weight limit on affected road bridges be used to limit accessibility? Reeves: The legality of map which did not represent the house could be brought into question Reeves: Can DEC prove they visited the site? Shields: Run it by Wayne for his input Guy Green: Use town's lawyer, put immediate correspondance out on lawyer's letterhead Shields: Call lawyer, draft letter, do within 24 hours? Fessenden: Mail letter asap to record our position?

All board members agree to act as soon as possible to follow up on this situation

OTHER BUSINESS: Fessenden: discussed GHA Insurance Paul Schmidt says Town agreed to share expense but that hasn't been addressed in 3 years Where Is original agreement? Can we find it in the Minutes? How far can we go to fund this? They are asking us to begin now without retroactive payments We'll need to decide in advance for budget Put on March agenda





Underwood: Employee Handbook; request Fessenden get a copy to each board member for review

Underwood: Gas Lease; apparently Town has 8 parcels of relevance to gas lease Will get paperwork to Board, see if there's any interest

Underwood: Dog enumeration, not now Contract for lawn mowing: put on March agenda
