

JUNE 14, 2006

A Regular Meeting of the Town Board of Genoa, Cayuga County, State of NY was held at Town Hall 1000 Bartnick Road, Genoa, NY on June 14, 2006

Present: Stuart Underwood, Supervisor Ken Manzari, Council Member Cheryl Shields, Council Member Dale Sellen, Council Member Lori Fessenden, Council Member Kate Beckley, Town Clerk

Also Present: Dana Mandel Hans Pecher Sjana Berry Donald Slocum

The meeting was called to order at 7:42 pm by S. Underwood with the Pledge of Allegiance to the Flag

ADDITIONS TO AGENDA:

Dana Mandel:

Addresses Board stating that Joseph Myers' ongoing construction at 8854 Route 90 clearly is the building of a residence, not merely the remodel of a garage as specified by his building permit Submits copy of Myers' Building Permit issued for "garage" addition

Submits photographs of actual construction and cites two-story addition which was not on plan,

replacement of garage door with residential door, installation of kitchen appliances, sofa,

swing set, mailbox, etc.

States that the actual structure being built is materially outside the scope and intent

of the plan which was submitted to the Code Officer

Cites misrepresentation used to procure a building permit, and non-adherence to the submitted plan Submits the idea that a residence is being built with the intention of violating the existing codes and with the intention of pursuing a variance once the residence is complete

Mandel asks the Board to examine local laws which require 40,000 square feet and 150 feet (minimum) of frontage for the building of a residence

states the Myers garage lot is only approx. 14,000 square feet with 94 feet of frontage

and has a substandard or failed septic system

Mandel requests an immediate revocation of the building permit and a Stop Work Order on the construction and asserts that no variance should be obtained by these means

Board agrees that Code Officer should be contacted

Fessenden: proceed with diligence to investigate whether or not structure is in compliance with the building permit Issued for it

Sjana Berry:

Discussed Cayuga County Farmland Protection Program Points out the Farmland Protection Board's lack of interest in extending the program to Genoa More interested in areas closer to Auburn Development is coming in from south however Asks Town Board to write another letter of support for the strong consideration of Genoa's inclusion in programs to protect farmland Lorie Fessenden will follow up as soon as she is able as the proposal deadline is end of June
