The check valve on line pump #2 has been replaced, it was leaking back by.

Had a new windshield installed in water truck. The old one cracked.

Have put together the AWQR (annual water quality report). The draft is done and will be sent to the CCHD (Cayuga County Health Department) for inspection before it is printed.

The brown out that we had on 2/29/08 caused some problems at the pump house. One of the contactors that runs a chlorinator pump burned up. The time clock that runs pump #3 was shorted out and the telemetry box that controls all of the line pumps was locked up. All of the problems have been taken care of.

In February, the ice and freezing rain seemed to be non-stop. We applied 522 ton of salt/cinder mix to our State roads and 340 ton on our Town and County roads. Our salt and cinder supply have been hit pretty hard.

Everyone seems to be in the same shape as salt supplies are about used up. The County highway is hauling and mixing sand to make their supplies go further.

Eric and Jake have been cutting brush, patching holes and filling washouts on the few warm days that we have. There are potholes where there have never been any. With the freezing and thawing and tractors and spreaders hauling all year long, it has taken a toll on the roads. Even the heavy truck traffic is year-round. Most of the other Townships have noticed this also.

I (Frank Sellen) spent most of the afternoon, a few weeks back, with an inspector from NYMIR insurance. He went in and around the buildings for safety purposes. He covered the pump houses, storage buildings, water towers and the Town Hall. We are in pretty good shape but we do have some infractions that need to be addressed.
