In March, we applied 267 ton of salt and cinder mix to our State roads and 135 ton on our Town and County roads. The winter has left our supplies very low. It will be tough to stay within next year's budget for snow removal, as we will have to replace our reserve supplies.

Jake and Eric have been patching and filling ruts. It looks as though they are getting caught up with the biggest share of them. Jake has been running the broom on our intersections and getting them cleaned up so the rain will flush them off.

Road oil has again been on the rise, making it a real challenge to keep up with our seal coating this year. The men dropped the plows and have begun hauling chipping stone and crusher run limestone. The plow equipment on the grader will soon be stripped. Our gravel roads are in need of grading, as the winter was tough on them also.

There is still plenty of work to be done in the shop. The winter left us with quite a few repairs to catch up on. They will be rainy day projects.

The men have been working on our NYMIR infractions and should have them complete soon.
