#### **OLD BUSINESS**

•The cleaning of the Town Hall was discussed. If someone new were to be hired, it would become a civil service position. Stuart will ask Barb Woods to clean the TH twice a month and will also set some guidelines. •It was suggested that there be less stone put in the parking lot so there will be less stone tracked into the building.

•Because the Town Courtroom is now in the lower level of the TH, there will be more traffic to the lower parking lot. The septic line runs under the parking lot and with added plowing during the winter and the cold temperatures, the lines have a tendency to overflow. The configuration of the parking lot may have to be changed.

•A new Rinnai heater may have to be installed in the Courtroom to help with temperature control.

•The noise issue between the Grant and Addy families was brought up again. The TOG has no noise ordinance. The State DMV has a law concerning the decible level.

#### **NEW BUSINESS**

Dave Stilwell has agreed to be the County Planning Board representative for the Town and John Berry has agreed to be an alternate. Peggy will compose a letter for Stuart to send to Dave and John. She will also email Steve Lynch about the appointments.

Purchasing a sign from Jim Kirkwood was discussed. The sign would sit in the TH yard for Town announcements. The purchase price is \$550. This includes a box of letters for the sign.
