The building permit fee was waived for the King Ferry Winery (they will recycle spray water) because it is in an agricultural district.

Heather distributed property reports to the Board members. She spoke about her plans for the future with regard to ag exemptions and property changes. If a reval is to be done in 2010, a resolution is needed this year. The Board will decide in December. Jeff Lowe said he will come to the October and November meetings to keep the Board up-to-date.

HIGHWAY REPORT

Sellen, Dale

The men have been finishing seal coating for this year. They have sealed and oiled about 9 miles all together. The streets in the hamlet of Genoa and the roads leading to the lake in King Ferry were the main roads done as well as two coats on the mile stretch of Center Road that we rebuilt last year. There are more that need sealing but the budget isn't going to allow it.

Jake has been mowing steady until switching over to the ditcher. There were a lot of spots that needed fixing from the heavy rain we had early in the month.

The men have been cutting trees and brush on Shingle Valley Road and running smaller limbs through a chipper. Hopefully, it should be ready for fabric and gravel soon. Eric dislocated his knee when a branch swung around and hit his leg. He can still drive, but is limited to what he can do.

The new loader was delivered on September 2nd. It was a little behind because of a two-week shut down at the plant. It came through with everything it was supposed to and a little more. It should be an excellent machine for us.

Frank purged the wells at the landfill, getting ready for the yearly testing. The water table was high enough this year to make it easier and quicker than in past years.

Frank has checked on getting a boom lift and ordered rope and anchor bolts for the cover replacement on the cover-all building. The price was \$6700 to hire it done. I hope we can do it quite a lot cheaper. On September 24th, we will be short a man as Bernie Thresher will be retiring after working for the Town for over 41 years. We should be advertising for employment soon.

The sale of the old water truck brought \$1350.

While mowing on the County right-of-way, Ralph Nettleton hit a plow shoe that had come off during the winter. The claim for reimbursement for lawnmower repairs is in the hands of the insurance company.
