HIGHWAY REPORT

In October the men were hauling gravel for the Towns of Venice and Niles to complete some of their road projects. They have, in turn, been hauling for us to Shingle Valley Road. On one of the days, we had 14 trucks hauling for us. So far, they've hauled about 3 thousand ton of screened gravel from Scott Binns' bank and 3 thousand ton of crushed gravel from Genoa Sand and Gravel. The east side is about complete and the west side should be done by month's end.

Eric has been running the grader and is getting better with the more seat time he gets. Jeff has been hauling steady with #4 and is doing fine. The transition between the older men and the younger guys seems to be going smooth, although the winter months will tell the story.

Jake has been mowing steady, and has caught up with the front side of the ditches and will be going back to catch some of the backsides where the farmers have gotten the crops off.

In the last couple of weeks, the weather has kept the men in practice putting on and taking off the plows and sanders. Some of the nearby Towns did have to sand, but we lucked out when it melted just in time. Frank and the nearby Highway Superintendents recently met with Southern Cayuga School District to discuss school closings and policies. Phone numbers were exchanged to help keep the communications open and to give advanced warnings when the pupils were being let out early. Hopefully, to avoid the confusion that was had a few years back.
