Don Potter spoke about his concerns regarding the Town's assessments. He sent a letter to Heather Garner, the Town assessor in April 2009 expressing these concerns. He feels there are errors with a number of agriculture exemptions. The Board was given a list of these concerns.

Mr. Signor was present at the meeting to disagree with the decision. The Supervisor informed Mr. Signor that the stakes were placed illegally according to New York State law.

HIGHWAY REPORT

The men have been doing a lot of ditch work on various roads. They have also been removing a lot of brush from the shoulders, trying to keep it back so that it can be mowed and maintained. Jeff and Mark have been hauling 1st stone from Seneca Stone and crushed limestone for stock piling for future use. Jake has been patching and cutting shoulders to allow water run off to our ditches.

Jeff has been working on the D-6 dozer in his spare time. He had to pull the radiator and re-core it so it would hold water again. He has also been working on the wiring and should have it usable again soon.

Frank has been talking with Steve Gauthier from Fisher and Associates about our three bridges on Creek Road. There may be a chance that one or two of the bridges may be eligible for funding through the Region Three NYS DOT. If accepted, they could be Federally funded by 80% and State funded by 15%, which would leave the Town responsible for 5%. The paperwork has already been started and could be submitted to them as well as the Town.

Frank has been attending Cornell Highway School this week. It was announced that the 2010 CHIPS money has been released for reimbursement. This should help to plan a project and know the money will be there to cover the budget appropriations.

James Sponagle, from our NYMIR insurance company, inspected our highway department, water facilities and Town Hall. Acting as their safety consultant, he covered about the same things as the PESH inspection and more. I am sure there will be corrections to come.
