The new Town signs are done and will be delivered to the Town Barn.

Supervisor Fessenden heard from Legislator Fran Mitchell with regard to the questions asked at the last Board meeting concerning the Biogas Project. Lorie will get back to those who asked the questions.

Board Member Sellen will have a signature card on file at the Cayuga Lake National Bank. Before the end of the year, the health savings plan for Town highway employees will be moved from the Elmira Savings Bank to the CLNB.

Possible candidates for the vacant board member seat were mentioned; Donna Grant, Stewart Underwood and J. Bothwell.

Board Member Armstrong will be the liaison between the Town Board and the Comprehensive Plan Committee

A possible court date of December 28 has been scheduled for the hearing of the suit brought against former Supervisor Peggy Bradley by George Signor.
