HIGHWAY REPORT

In January the men applied 312 ton of salt/cinder mix to our State Roads and 273 ton of mix to our Town and County Roads. Even with the absence of snow fall, the thawing and refreezing of the road surfaces at night have required sanding.

Men have been cutting wood, little ditching and repairing equipment in the shop. They finished the front drive on the grader and that should be ready to go. They also built a cover for the air conditioner at the Town Hall to protect it from ice falling from the eves.

Frank had a meeting February 3rd with Fisher Associates. They were picked by our selection committee to engineer our bridge replacement on Creek Road. Frank discussed details regarding alignment, land purchase, utility relocation and scoping of the project. More details can be seen in your minutes of the meeting, that each of you should have.

Frank discussed reimbursement from the State Highways we maintain during the winter months with George Wethey from Cayuga County Highway. Even though Frank submits State forms monthly, he will now be using a spread sheet to more closely account for each man hour, truck hour, type and quantity of material applied. This will also look better to the State Auditor.
