## **ASSESSOR'S UPDATE**

Lorie read the December 2012 Assessor's Report

It is exemption time again. Renewal applications have been printed at the County Real Property Office for the first time this year. I will have all renewal applications mailed by the end of November. All exemption applications are due MARCH 1<sup>st</sup>. I will send an application for the Income Verification to each property owner receiving Enhanced STAR that does not currently have an application on file again this year.

All property owners receiving Agricultural, Senior Citizen with low income, Enhanced Star or Disability exemptions must re-apply each year.

On November 14, 2012, I had the opportunity to present at the Women in Tax Assessment Group with Lezli Parsons, Sterling Assessor and Kelly Anderson, Cayuga County Real Property Director. There were quite a few people in attendance. The presentation was broadcast to several locations throughout the State. Kelly, Lezli and I shared aspects of the revaluation process that can be troubling and focused on sharing tools and techniques to minimize those areas. The men have been working in the shop getting the grader put back together. The plow equipment is on and ready to go if we need it. The lift cylinder on #9 is rebuilt and back on. The seals were installed in the front of the motor and Eric has been hauling with it.

The men have been cutting back brush and trees that were hanging out from the last winds we had. Matt has been using the ditcher for the harder to reach limbs.

Mark has been taking advantage of the weather and mowing more of the backsides of the ditches before winter sets in.

The new John Deere loader was delivered on the 21<sup>st</sup>. Instead of the yearly program, the Government has made the dealers go to a 2-year buy-back agreement. The new loader we received has the new tier 4 motor, (a \$10,000.00 upgrade) plus quick-attach forks, 4 in one bucket, GP bucket and high lift arms.

Parrott/Wolf completed the extra borings for the bridge project. It was determined that extra pylons would be needed on the west side to get down to the bedrock and control scour.

We were informed by the State D.O.T. that straight salt will be used on the State roads that we maintain through the winter months. NO more mix is to be used on their roads. This will have to be discussed by the board members to determine our options.

Dale is going to speak with George Wethey, Cayuga County Highway Superintendent about the salt issue. The Town doesn't have the right equipment. This would mean less money for the Town if the County takes over the salting of County roads but it will also be less expensive for the Town. There would be less overtime and the amount of fuel used would be reduced.
