## **HIGHWAY REPORT**

In March the men applied 223 ton of salt cinder mix to our State roads and 210 ton on our Town and County roads. The men have been working in the shop taking the plow equipment off and cleaning them up, getting them ready for storage.

The men have been hauling crusher run stone from Seneca Stone and stock piling it at the landfill for summer use. Jeff has been out cleaning up spots from the wing with the broom and the York rake. Eric has hauled patch, and been out filling pot holes left from winter.

Our State has secured more money for the CHIPS program. Our increase amounted to approximately \$23,000.00, which will bring our total up to about \$103,000.00. This should add a couple of miles to our chip seal program and help to maintain roads that would otherwise be overlooked.

Fingerlakes Communication has installed 10 new mobile radios in all our equipment. Emergency Management allowed us 3 hand held units as well, to be used for traffic control. So far the system seems to work fine. All of these units are capable of contacting 911 directly and can monitor other channels as well.

Justice Bennett spoke to the Board about the conference he attended in Albany. One of the main topics discussed was a group calling themselves "Sovereign Citizens". This is a group who are causing problems with Town Courts and Court employees. NYS will now bond all justices and their employees.

In September, 2012, a new DWI law went into effect.

Kim will need a check for \$4000 as a deposit for the new security door for his office. This is part of the grant he was awarded. He has also purchased 6 chairs for the jury room.

Lorie told him that a resolution is needed to establish a constable position for the court. Kim said that isn't what he is asking for and he and Lorie will meet at a later time to discuss the issue further.

#### **OLD BUSINESS**

The broadband grant that was approved for the area doesn't include sufficient funds so Ledyard is lacking \$150,000 for a tower. Clarity Connect may start installation in about 4 weeks. Lorie continues to revise the Employee Handbook.

Lorie has made contact with New Wave Energy Company. The Town should see a savings by switching to this energy company.

The Sharpsteen Cemetery request is still being discussed.

Lorie asked if it is necessary for the Board members to retake the NIMS 100 test.

There are logs in Salmon Creek between the ball field and the Fire Department plus debris.

Because this is a trout stream, it cannot be disturbed.

Dale attended the March 21 Hazard Mitigation meeting and shared the information and follow up with Cheryl who reported this to the Board.

## **NEW BUSINESS**

The Supervisor was made aware of NYS Department of Labor law Section 27-a regarding elevators/the fire department.

Zee Medical submitted a proposal to the Town with regard to an AED Program. The Board doesn't want to participate. This has to do with having a defibrillator on the premises and also at the Town garage.

The second quarter payment has been sent to Southern Cayuga Instant Aid.

Dear Town Supervisor Lorrie Fessenden,

I am writing this letter in regards to home heating fuel. I am currently spending two-thirds more than I would otherwise spend, had I the capability to access natural gas. Would you kindly inform me why Town of Genoa constituents do not have the same opportunity to access a more clean, sustainable, cost-effective method of heating our homes, as say, the constituents of Locke, Moravia, Lansing, Ithaca and Auburn? It is my information that Wells College had wanted to access the natural gas grid a year or more ago and was unable to do so viz a pipeline. I have read that Governor Cuomo had issued a press release in Jan. '13 in regards to mandating that the utility companies work with NYS's Public Service Commission and elected officials to increase the amount of constituents with access to the grid, for alternative energy sources.

My thinking is that this would be an excellent time to make use of such an initiative/program with a future focus of acquiring an environmentally healthy and cost-effective method of heating our homes here in Genoa. At the same time, I also feel that this would be an excellent way to combat the market devaluation of home and property values here in Genoa. My husband and I purchased a home here almost three years ago and have watched it depreciate to nearly half its value, on such real estate-market Internet sites such as Trulia... I do believe that having a modern and cost-effective home energy source would help to defray such market decreases of the average homeowner's real estate value, in a housing market still suffering from 'The Great Recession.'

I have contacted the NYS Gas and Electric Co. and spoken with several people there. I have been informed that they cannot bring a pipeline to Genoa as they do not have a town franchise and to complete such a contract with the town, would take anywhere of a period of eleven to fourteen

months. I have also been informed that the company would have to come a distance of approximately six miles for an approximate cost to install said pipeline, of \$1.2M. These estimates were figures approximated in the most general terms...

I want to urge you to initiate the machinations for modernizing and improving Genoa's accessibility to a more affordable method of heating our homes and with the utmost expediency. I am positive that any email survey conducted would reveal that the saving of two-thirds of constituent's energy costs would be considered a most desired and urgent matter to most people of Genoa. Personally, I am troubled when I have to spend two-thirds more for any product than my neighbors in the surrounding area, and I'm sure that others would agree. I have to believe that there are state or federal funds available to subsidize this initiative. Government should be in the business of public service. They and their vendors should not be in the business of making a profit, but rather to provide the best service to improve the quality of life to their customers. In my opinion, energy solutions should be a governmental 'top priority.'

Currently, our home in Genoa has five method's of home heating sources: coal, wood, propane, electric and oil. None are as practical as what we have available at our other home, downstate: natural gas; which is safe, clean, convenient, and a third of the price. I feel that the issue of protecting the public's health, safety and well being should be a priority of local government. Further, I feel that local government should have a plan to provide their constituents with fair and equal housing and energy prices with a future focus on sustainability. Please advise...

Please contact me with any questions or modifications for information of this letter. Please let me know if there is anything I may do to help as I would like to I have a high record and deep

know if there is anything I may do to help, as I would like to. I have a high regard and deep fondness for this beautiful town and would like you to know how much my husband and I appreciate the work you do and have done, to make Genoa such a wonderful place to live.
