#### **HIGHWAY REPORT**

**Brandon White** 

In January the men have applied 102 ton of salt and cinder mix to the County roads and 132 ton of mix to our Town roads. With the colder temperatures and the winds we've been getting, they plowed more and cindered less. Mark has been out with the loader opening up the drives to the water tanks. Matt has been cutting shelves with the ditcher and wing, this helps with the drifting.

The Town Highway had a surprise visit from the NYS Department of Labor. The buildings were inspected inside and out, along with the Town Hall and the Water Department for violations in the work place. There were a minimal amount of infractions for each building. Some of the violations were corrected while he was still here, some will take longer.

Phil Kenyon and John Conner stopped at the highway garage to give us written estimates for changing out the electric fixtures and installing the new high bay lights in the truck bays.

Frank had Cortland Overhead Door install new safety pressure sensors on the overhead doors. The inspector found them not working and in despair. They will also be replacing the seals around the doors that have been worn and torn from usage over the years.

#### ASSESSOR REPORT

Exemptions are due VERY soon. All property owners receiving Agricultural, Senior Citizen with low income, Enhanced Star or Disability exemptions must re-apply each year. All exemption renewal and 1<sup>st</sup> time applications and documentation are due by March 1, 2014. Resident-property owners turning 65 years old by December 31, 2014 may be eligible for the Enhanced STAR and/or the Low income Sr. Citizen exemption(s).

Veterans may also be eligible for an exemption depending on when and where they served during their military service.

Taxable Status date is March 1 as well. This means that property will be valued for 2014 assessment roll as it stands on March 1.

Mick provided me with the list of Building permits for the year. This helps to identify changes needing review a great deal and is very much appreciated.
