Met with Chris Colvert, NYSDOT Engineer, about water problem on Route 34B (Bud Ward's house). Bob Hunt says it is not a water main leaking. We have not heard back from the DOT yet.

The men were out trimming and chipping trees and brush a couple days.

Truck # 6 replaced pulleys and pins for wing plow, replaced rear hub bearings and studs. Fan housing bolts on engine broke, needed to remove and replace them.

The men are still cleaning and painting in the shop.

Paul mentioned that just today he talked with Chris Colvert. It is not the water main leaking. It is a leaking concrete pipe that is the responsibility of the State.
