HIGHWAY REPORT

No major snow storms, getting enough snow to require plowing and sanding.

Work on our Volvo ditcher has been completed by Stephenson Equipment. Cayuga County Highway hauled it back for us.

We had a manure pond north of town leaking manure into Salmon Creek. Bob and I kept track of the town's water by taking samples to JLI Laboratories for testing. All tests came back negative.

We had a rusty pipe at the water plant that needed to be replaced. Drained the reservoir, pulled the pump, removed old pipe and welded in new pipe. Bob and Eric have been scraping and painting the water pipes in pump house.

The men have started hauling crushed stone from Seneca Stone.

Lorie asked the Board their thoughts on billing the farm responsible for the manure leak. The Board agreed this was a good idea.
